Because of weak demand for LED Protector PLED6M Series, Littelfuse would like to notify you the obsolescence of PLED6M Series. Littelfuse will no longer supply part number PLED6M in POWERMITE package, but instead we propose part number PLED6N in SOD-123FL package as its replacement part, which is expected to be released by end of Q1 2017. These two products are electrically identical, but are in different packages.

Meanwhile, our last buy date of PLED6M is Jan 10th 2017. Thus we strongly suggest customers to build enough buffer quantity to cover the 2017 demand due to customer qualification period of PLED6N.
