DESCRIPTION OF CHANGE(S)

Manufacturing of DPA422 has discontinued since the closure of XFab in Dresden, Germany. DPA423, another product in DPA-Switch™ family is qualified at Lapis wafer foundry located in Miyazaki, Japan and is recommended as the replacement product.

REASON FOR CHANGE(S)

The wafer fabrication facility, XFab Dresden has ceased operation of its six-inch wafer processing line ~~since June 2013~~.
